No "walk-arounds", entertainment, outside posters, handbills, sandwich boards, menus, sales information or distributing literature, etc., is permitted outside of your space. If you need something set up in front of your tent, please have the tent set back off the road a few feet. The roads need to be clear for fairgoers and emergency vehicles. Exhibit material cannot overflow into the aisles. Additional materials must be stored neatly out of sight of Fairgoers. These terms pertain to both indoor and outdoor vendors. Initial
